Only days before the much-anticipated test, she gave in to the heavy constraints of scholastic expectations. Writing a heartbreaking suicide letter to her parents, she described her extreme feelings of worthlessness and hopelessness and argued that she had the fortitude necessary to face the demands of the upcoming test. Referring to herself as "the worst daughter," her moving words revealed the extent of her mental suffering. Full of self-loathing and regret, the letter left her parents very saddened, struggling to fill the deep hole left by their child's premature death.

Forensic linguistics, placed at the intersection of language research and legal inquiry, offers significant insights into the dynamics of communication in legal contexts. In order to evaluate language in legal circumstances, this interdisciplinary field draws on concepts from psychology, linguistics, and law. In forensic linguistics, pragmatic analysis is a crucial aspect that centers on the way language is employed in context to transmit meaning that goes beyond literal interpretation. Understanding the author's underlying goals and feelings is crucial when dealing with delicate topics like suicide notes; hence, this approach is especially pertinent in these cases. Given this context, it becomes critical to comprehend the linguistic elements of the suicide notes left by teens in Kota. This study attempts to shed light on the psychological pain and difficulties that young people in this scholastic pressure cooker suffer by analyzing the language employed in this note.

This depressing incident highlights the dark underbelly of the prevailing culture of ruthless rivalry and high performance standards in educational districts like Kota, which are known for their strict coaching institutes. It is a moving example of the damaging effects that academic pressures have on developing minds and emphasizes the urgent need for strong mental health support systems in these kinds of learning environments. Communities are still dealing with the devastating fallout from this tragic loss, but there is a clear need for coordinated efforts to prioritize students' overall health in order to provide them with the necessary support systems and coping mechanisms to match the complex challenges they face. In order to prevent similar catastrophes in future eras, proactive mitigation techniques can only be successfully implemented through diligent efforts to address the underlying causes of mental health crises.

Six documents, including Virginia Woolf's literary works and suicide notes, were assembled into a corpus for this reason. Next, the LIWC (Linguistic Inquiry and Word Count) program was used to examine each text. Principal Component Analysis (PCA) was used to reduce the dimensionality of the analysis results due to their complexity. Grammatical mistakes are a common occurrence in the letters Jun writes to herself.

Linguistic Meaning of Xi'an Student Suicide Letters, used a qualitative approach and the research data is suicide letters (Khoirunnisa & Delijar, 2023). In their research found that suicide perpetrators used words referring to traumatic situations during sexual abuse and continued to commit suicide as a way to overcome the trauma they experienced. In their research used a theory according to Chaer, If the object of investigation is the language lexicon, then the meaning of the semantic type is called lexical semantics.




Figure 1 Suicide notes of Indian Teenage Girl.

Simultaneously, the note contains implicit statements of regret and self-reflection, seen in phrases such as "I worst daughter" and "Sorry mummy papa" The author's expressions reflect their intense emotional suffering, exposing a strong feeling of remorse and humiliation that underlies their choice to take their own life. Therefore, by skillfully combining direct and indirect communication, the suicide note successfully portrays the intricate nature of the author's mental state, encouraging readers to explore the profound depths of their suffering.

## 3.1.3 Interpretation and Understanding

The analysis of the suicide note depends significantly on the reader's capacity to comprehend and decipher the implied connotations and emotional subtleties hidden within the text. The author's parents, as the recipients of the note, have the responsibility of interpreting the hidden signals and fully understanding the importance of their child's words. References to familial relationships and sentiments of regret are important contextual indicators that offer valuable insights into the author's emotional state and motives. Moreover, the structure and linguistic selections of the note function to direct the reader's understanding, indicating the writer's objectives and evoking particular emotional reactions. Hence, the
